

Dear Membership:

It is an incredible honor to be your president this year. I know I have some big shoes to fill; Nancy Hawkins and our Board led beautifully last year, ushering in one of our largest provisional classes and working hard to get us moved into our new office. All this on top of managing a variety of projects and developing relevant trainings for our GMMs. 2016-17 was a huge success!

My goals for the League this year come from a belief that, first and foremost, the purpose of the Junior League is to make a difference in the community. Making small changes to help those in need at a local

level is how you overcome the hate and turmoil happening on a global level; you make the world a better place by starting right next door. I hope to do this by strengthening member engagement within the league and in our community, and by looking at new ways to contribute to all of our partner organizations.

The past three years have brought an influx of new members, and so we were able to increase the number of service projects this year. In addition to the County Harvest Food Rescue Program; cooking and delivering food to the Westchester CSA; collecting and distributing clothing and baby items through Pass it On, Pelham!; and the Dorm Room Drive; we'll develop a reading and art program with the Pelham Public Library and we'll research the need for a professional training program in the community. We will continue to facilitate the delivery of food to children in New Rochelle via our Backpack Program. And by the end of this year, our research and development team—with your help—will identify our next Signature Project.

We're livening up our provisional process this year with a robust one-day training session and a Pelham-themed scavenger hunt. This year's class will help to create a Martin Luther King Day of Service Project for the town of Pelham - it's something that the community has expressed a need for, and I know the Junior League can deliver.

Finally, I want to leave you with a quote from a fellow Junior Leaguer, and one of my heroes in the kitchen and beyond: Julia Child. "The measure of achievement is doing something that you appreciate; it's doing something that you think is worthwhile." It is very important to me that ALL league members feel that their work is worthwhile, and that we all follow in Julia's footsteps and be curious, bright, and fearless. I encourage you all to please reach out to me with ideas, suggestions, concerns because this isn't "My Year" or the "Board's Year": this service year belongs to all of us, and I want us all to work TOGETHER to build a better Pelham.














## Cinco de Mayo

## **JLP Projects**

JLP Project Chairs and volunteers worked hard on the five main outreach projects for the 2016-2017 year and had a important impact on the community.

#### **Backpack Program**

This year the Backpack Program completed nine major delivery runs. Recipients included large groups and individual families. Recipients included Boys & Girls Club of New Rochelle, the Good Counsel Home in Mount Vernon, the Acacia Network in the Bronx, Lincoln Hospital in the Bronx, Hope Community Services in New Rochelle, BronxWorks, and LSA Family Health Services in Harlem. We also worked with Hearts and Homes, and delivered three large bins of spring clothing to a local Syrian refugee family. The individual family recipients were generally referred to us by members or via the Moms of Pelham Facebook group.





#### **Dorm Room Drive**

This year was a planning year for this project. The project goal is to support first-generation college bound freshman women as they embark on their college careers by outfitting them with door room essentials.

#### Pass it On, Pelham!

Pass it On, Pelham! continued to collect baby and children's gear from Pelham families and delivered them to families in need. JLP moved its office from Huguenot Church to the Manor Club and Pass it On, Pelham! will also be housed in this space. Pass it On, Pelham! was the beneficiary of this year's provisional project. The provisional team held a family-fun collection event in February at the Manor Club and help moved items to the new location.

#### **County Harvest Food Run Rescue**

JLP Continued to support County Harvest by participating in a weekly food run, rescuing excess food from restaurants, supermarkets and wholesale clubs and delivering it to soup kitchens, food pantries and homeless shelters in Westchester.



JLP Recognized by the Boys & Girls Club of New Rochelle

The JLP was awarded the "Afterschool Hero Award" from the Boys & Girls Club of New Rochelle for the work the League has done with the Backpack Program over the years. The Backpack Program provides backpacks full of nutritious food every other Friday to the Boys & Girls Club of New Rochelle which distributes the food to its neediest families. Maggie Shaw accepted the award on behalf of the JLP on October 19, 2016 at an event called "Lights on Afterschool" which celebrates the work of afterschool programs.









#### **CSA Dinner Programs**

New project "CSA Dinner Programs" partnered with Community Service Associates (CSA) to provide dinners to those in need in the Mt. Vernon community. Committee members met monthly at rotating homes to prepare an entree, starch, vegetable side and dessert for 100 people. Nine deliveries were made by twenty JLP members throughout the year, totaling 900 delicious meals. We had fun cooking together and learning how to make enough for a crowd.









## Provisional Pass it on, Pelham Event a Success!

n February 4, 2017, the Provisional Class hosted hosted a drive to collect gently-used baby gear and clothing for kids aged 0-16 at the Manor Club in connection with the Pass it on Pelham! Project.

Over 30 bags of clothes, shoes, and baby gear were collected for families in Pelham and surrounding communities. The JLP coordinated deliveries throughout the year with beneficiaries such as St. Dominick's Foster Home in the Bronx to get the donations directly into the hands of families in need.

"It was an amazing event," said Past President, Tyson Newton Stephens. "Not only were people able to clear out some extra clothes and gear, they were able to make a real contribution to Pelham and the surrounding areas. There was one man who brought in over 15 large garbage bags of clothes - all with a great big grin!"

In addition to collecting donations, the JLP hosted entertainment for the whole family, including music by Zev, Juggles the Clown and crafts for St. Valentine's Day. Over 40 parents and children came to donate and enjoy the activities.

Community Leaders Roundtable: Building and Strengthening Partnerships: Exploring Community Needs and Creating Meaningful Solutions for Pelham Non-Profits, Businesses and Civic Leaders





n October 26, 2016, the Junior League of Pelham (JLP) held a Community Leaders Roundtable at Daronco Town House. The roundtable focused on cultivating meaningful and lasting relationships with customers and the community to forge powerful partnerships to the benefit of all. Stakeholders from the business, non-profit and civic sectors participated in the discussion. The panel was facilitated by JLP Community and Public Affairs co-chair, Kimberly Davis.

## Insights from the panelists:

Luisa DeCicco: DeCicco & Sons Representing the corporatesector, the Director of Human Resources focused on the importance of building relationships. She spoke about creating relationships between employees and customers, and illustrated how their organization supports the communities in which they operate.

Lynn Honeysett: Pelham Art Center. The Executive Director highlighted collaboration as



the community—through
workshops, exhibits, and public
art—to make art more accessible
to all. Partnerships have included
close neighbors such as
Prime 16 and the Yoga Studio.
Honeysett believes that
successful partnerships are based
on collaborative goals; that
they must be open and flexible;
and all sides must contribute.

Susan Mutti: Village of Pelham. The Deputy Mayor explained that the Village of Pelham's partners include: the residents, government bodies, organizations, merchants, and the MTA. She provided the audience with a highlight of how the Village collaborates and works with these various partners. Residents may have concerns, initiatives,

projects and other issues such as parking and zoning. Government bodies have best practices, shared services, training and projects. Organizations in town require approval for events (e.g. parades) or to accept donations (e.g. to plant trees). When it comes to merchants-the laws change and they need new and revised permits (e.g. expand sidewalk service), ARB (signage code, site reviews) or parking. Finally, the MTA-station conducts its own renovations, safety and parking but works with the Village of Pelham.

Joe Solimine Jr: Meridian Risk Management. The President of both Meridian Risk Managemen and the Pelham Chamber of Commerce explained the challenges that small business face, when competing with larger firms, and emphasized that creating relationships

can make the difference in their success. Meridian Risk Management is now synonymous with volunteering and giving in Pelham— "Give where you live" is their philosophy. Loaning office space and donating to local non-profits are just some of the ways Meridian supports the community; forging enduring partnerships with JLP, Pelham Civic Association, The Picture House, Pelham Children Center, Pelham Art Center and The Pelham Public Library.

The workshop that followed challenged the audience to identify community needs and explore how partnerships could make a difference. Best ideas were then shared and presented to the group at large.

#### **Backpack**

Through the JLP Backpack program, we provide 25 of the neediest families who attend the Boys & Girls Club of New Rochelle with totes full of healthy food to sustain them over a weekend. These families rely on subsidized or free meals in school during the week, but on the weekends they are left with no assistance to sustain themselves.

#### **CSA Dinner**

CSA Dinner Programs will be a partnership with Community Service Associates to provide dinners to those in need in the Mt. Vernon community. Cooking days or nights will be modeled after Pie-Baking to

encourage member socialization while getting hands-on in the kitchen and will be open to all members. Committee members can also decide to serve the meal at the CSA.

#### **Dorm Room**

Dorm Room Drive will support first-generation college-bound freshman women as they embark on their college careers by outfitting them with dorm room essentials such as comforter sets, sheets, towels, pillows, and shower caddies complete with toiletries.

#### **Food Rescue (County Harvest)**

County Harvest is a non-profit organization that rescues excess food from hotels, restaurants,

caterers, country clubs, supermarkets, wholesale clubs etc. and delivers it immediately to soup kitchens, food pantries and homeless shelters in Westchester County. JLP members will participate in a weekly food rescue run.

#### **Library Partners**

Library Partners is a partnership with Pelham Public Library in which members of the committee will read at children's story time twice a month with children ages birth-4 years old. The committee members use picture books, stories, rhymes, and songs to enhance early literacy and to have lots of fun. In addition, this year we are also doing a craft/

art project one Saturday a month.
Two committee members will
engage children ages 5-8 year olds
in a book related craft.

#### Pass it on, Pelham!

The goal of Pass It On, Pelham! is to connect gently used infant and children's clothing with local families in need in cooperation with community organizations. The project will hold collection events to receive donations and will develop a network of organizations so that donated goods may quickly reach those who can use them.

#### Professional Prep – NEW!

The goal of this project is to help

Mothers/Fathers re-entering the work force, or high school/ college grads getting ready for their first job. We plan to assist applicants with their wardrobe and help them with their resume writing and interview skills. Through wardrobe assistance, we can connect those people looking for professional attire with those who have donations. Through resume and interview assistance, we will help people preparing for a job interview. Qualified JLP members can volunteer to review and edit resumes, and conduct mock interviews (based on their different industries/ areas of expertise).

On November 15th and 16th, over 70 JLPers baked 28 apple pies for the CSA of Mount Vernon. They also stuffed stockings full of candy, pencils, crayons, coloring books and small trinket holiday toys. ## **NYSPAC**



Representatives from Junior Leagues across the state of New York gathered in Albany on Saturday, November 18th, for the annual Fall Conference for the New York State **Public Affairs Committee** (NYSPAC), to learn about coalition-building and advocacy, and identify a focus for NYSPAC advocacy for 2016-17. NYSPAC is a coalition of 17 Junior Leagues from across New York state, representing more than 7,500 women, with a focus on public policy, and having a positive impact on women, health, children and families. Pelham Manor residents, Kimberly Davis and Romina Levy, attended to represent

the Junior League of Pelham. The following issues were considered:

- "Raise the Age" legislation
- Legislation that prevents employers from asking prior salary in job interview and application
- Legislation that prevents Level 3 (most likely to reoffend/violent) sex offenders from living in college dormitories
- Updates to statute of limitations for child sex abuse
- Legislation to require hospitals and other health organizations to identify and report suspected cases of human trafficking

After much discussion, 10 of the 11 leagues in attendance voted, resulting in an agreement to advocate in support of passing legislation that prevents employers from asking prior salary in job interviews and on applications. For more information about NYSPAC: http://jl-nyspac.org/

# Junior League of Pelham announces its 2017 Grant Recipients

The Junior League of Pelham (JLP) is pleased to announce the 2017 recipients of its annual Community Grants Program. All of these non-profits support projects and services aligned with the JLP's focus on healthy families, education, and Pelham improvements.



**Ladies of Charity** is a not-for-profit organization focused on women's and children's causes, and supports the Pelham Day Care Center. JLP provided \$500 to purchase yarn to make children's mittens & blankets.

**Pelham Children's Center** is a not-for-profit early child care and education center serving a culturally and economically diverse group of children. The JLP grant of \$2,000 will be used to cover a portion of their food service program.

**The Manor Club** is a not-for-profit organization whose mission is to promote and provide cultural, educational, literacy, and philanthropic activities within Pelham and its surrounding communities. The JLP granted \$750 to sponsor a lecture series targeted at middle school and high school students, in cooperation with the Women's Empowerment Group at PMHS.

**Pelham Art Center** received \$1,000 to support the outdoor Art Exhibit installations in the designated area of Wolfs Lane Park. The Pelham Art Center is committed to providing high-quality, free and affordable art programs year-round to Pelham and its surrounding communities.



**Cancer Support Team** is the only Westchester based non-profit home care program, whose mission is to enhance the quality of life of patients and families affected by cancer. The JLP grant of \$500 will be used to purchase supplies to make Chemo Comfort kits.




**Project Community Inc.** (formerly known as Nurses Network) began over 30 years ago when nurses partnered with their community to provide healthcare knowledge. The JLP granted \$750 to fund a presentation to 8th-9th graders in Pelham on the dangers of binge drinking.

**Siwanoy School PTA** received \$500 to support its outdoor classroom that will break ground this summer. This space will allow teachers and students in all grades and various subjects to use the natural world as an integral part of learning throughout the entire year. We had a number of outstanding applicants for our President's Award Scholarship, but the committee quickly agreed that there was a clear winner. Teddy Carey embodies all the traits we were looking for: he has volunteered extensively with a number of organizations in town, including Huguenot Memorial Church, the Pelham Education Foundation, the Pelham Memorial High School Tutoring Center, Relay for Life, and Thanksgiving in a Box.

His grades demonstrate an admirable work ethic, and he's heading to Georgetown University in the fall. He received a glowing recommendation. But what inspired us most about Teddy was his essay. In it he tells the story of his family's work with the Fresh Air Fund, and how they hosted a young boy named Junior from Harlem in their home each summer for two weeks, beginning when Teddy was just 8 years old. He started off being a little annoyed at having to share his room with a strange kid, but he and Junior became close friends over the years. And, just as important, he learned one of life's greatest lessons very early on. He writes, "As the years passed and I got more mature, I realized the rest of the world was not always as safe and as easy as Pelham. Not everyone is entitled to the same privileges as I am. I knew I could never change that, but I found out I could do a little bit to help in any way possible. After that realization, I started volunteering for anything that seemed important to me. If I possessed a skill or ability that I could share with someone else, then I did." We look forward to seeing where Teddy's intelligence, insight, and compassion will take him.

#### **Wolfs Lane Park Project**

Former Pelham Village Trustee and JLP Sustainer, Susan Mutti, worked tirelessly on the Wolf's Lane Park project since she assumed control of the entire project in 2013. The Project for Public Space of 10+ Philosophy is an expansive project that demonstrates how the Pelham community can thrive, socially, by allocating public spaces for a variety of social activities. Those activities, in turn, derive an economic benefit, by attracting residents to the village's traditional commercial district.

The Wolf's Lane Park's first completed project was JLP's very own signature project, the Woodland's Park, opened September of 2015.




#### **Amy Moselhi**

We are so excited to welcome next year's Sustainer-at-Large Representatives Kristen Timmermans and Colleen Walsh!



## Membership Training at our General Membership Meetings




In addition to socializing with friends and getting caught up on what is happening in the league, this year's GMMs were heavily focused on leadership training and we had some excellent guest speakers.

In October, Carol Hindcliffe from Thrive Fitness & Nutrition Studio about mindfulness, life balance and mediation.


















#### **GMM Minutes**
